## **Targeted statutory consultation opens on Thurrock 3 - proposed changes to connection at Tilbury**

We're consulting on some proposed changes to the connection at Tilbury. The consultation starts on Tuesday 18 March and closes at 11:59 pm on Thursday 17 April 2025.

This is one of a series of targeted consultations on some potential changes to the proposals we published at our statutory consultation in summer 2024.

Most of these changes have been identified from feedback we've received. Before we make any decisions, we want to consult local residents and community representatives.
